

Preschool Reporting Form Instructions

The PRESCHOOL Safe Environment Certification form is required every for parishes that have a formal Preschool program in order to certify Safe Environment compliance of all adult employees and all adult volunteers working with minors per the USCCB Charter for the Protection of Children and Young People.

- This form is for **parish preschool** staff and volunteers only. Because the preschool is not usually a ministry of the school, compliance is not being counted by the school.
- If it is verified that the school principal will include this information in the school report to Office of Catholic Schools, please notify Alex.Kwan@archden.org so that it can be noted.
- This is a "snapshot" report and should only count employees and volunteers with minors active as of 12/31/24.
- The counts provided should be retrieved from and match information in the VIRTUS database.
- The Archdiocesan requirements of Safe Environment compliance are outlined in the <u>Pastor/Parish SE Checklist</u> which is available at archden.org/protection/site-administrator-resources/

Section 1: Adults Initial Training/ Initial Background Check/ Current Code of Conduct:

The AOD requires that all adult employees and all volunteers with minors take refresher training and have a new background check every 5 years. Indicate status of refresher training and background checks due in 2024.
